

# **RICHMOND ELEMENTARY SCHOOL**

## **Parent and Family Engagement Policy**

In support of strengthening student academic achievement, **RICHMOND SCHOOL** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). **DESCRIPTION OF HOW THE SCHOOL WILL IMPLEMENT  
REQUIRED SCHOOL PARENT AND FAMILY ENGAGEMENT POLICY COMPONENTS**

**Section A: JOINTLY DEVELOPED**

**Richmond School** will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

- **Parents will be involved in the development of the school parent and family engagement policy by attending SAC/Spring Title I Parental Input Meetings. Parents were invited to take part via a calendar reminder and a flyer, as well as by verbal invitations. During the meeting, parents were given the opportunity to provide input and suggestions related to the parent and family engagement programs. This year the parent input meeting took place on April 22, 2020.**

**Section B: ANNUAL TITLE I MEETING**

**Richmond School** will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

- **The Annual Title I meeting to inform parents of the requirements of Title I and the school's participation as well as the parents' rights to be involved is held during Back to School Night, which is scheduled for Thursday, September 24, 2020. This meeting will also include a presentation on the state academic standards and assessments (PSSAs), how to work with educators and progress monitor student academic and attendance data, information about the school curriculum and parent rights and responsibilities under Title I part A.**

**Section C: COMMUNICATIONS**

**Richmond School** will take the following actions to provide parents of participating children with (1) Timely information about the Title I programs, (2) Flexible number of meetings, such as meetings in the morning or evening, (3) transportation, child care or home visits, as such services relate to parent and family engagement and may use Title I funds and (4) Information related to the school and parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents can understand.

- 1) For students in grades K through 3, the Parent and Family Engagement Policy will be included in a pre-printed folder and distributed to all parents at the beginning of the school year. The folder will be used to share communications about upcoming parent meetings and events with parents.
- 2) For students in grades 4 and 5, the Parent and Family Engagement Policy will be included in a pre-printed agenda book and distributed to all parents for student use at the beginning of the school year.
- 3) SAC Meetings will be scheduled and held monthly, with meetings varying in times (8:45 during school hours, 3:09 after school hours). Family Night events and Back to School Night are held in the evening. Winter and Spring Title I Parental Input meetings are held in the mornings at 8:45 am and/or 3:09 pm to maximize parental involvement.
- 4) Monthly Calendars and flyers are created and sent home to parents to inform them of upcoming school events including but not limited to Back to School Night, Report Card Conferences, Parent Workshops, Family Night, in three languages.
- 5) Translations are available, as needed, through the support of the Office of Translation.

#### **Section D: SCHOOL-PARENT COMPACT**

Richmond School will take the following actions to jointly develop with parents of participating children a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the state's high standards.

- During a monthly SAC (School Advisory Council) meeting in April, parents, administrators, and teachers will meet to jointly develop the school-parent compact. This year the meeting took place on April 22, 2020.
- Parents will provide input for the compact by sharing ideas on how the school staff, parents, and students will build positive partnerships and help students to achieve academic standards.

#### **Section E: RESERVATION OF FUNDS**

Richmond School will take the following actions to involve the parents of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for parent and family engagement is spent by:

- During the Winter Title I meeting in January parents participated in a budget meeting and in the decision making process regarding how to spend Title I funds reserved for parent and family engagement.

## **Section F: COORDINATION OF SERVICES**

**Richmond School** will, to the extent feasible and appropriate, coordinate and integrate parent and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children by:

- **All parents of registered incoming kindergarten students for the 2021-2022 school year are invited in June 2021 for a “Getting Ready for Kindergarten” workshop. The workshop is held in two sessions. Information about the school and our kindergarten program is shared, as well as materials given to parents to assist their child in getting ready for school. Incentives are given so that the students complete work packets over the summer. Two open house days are held for parents to visit the three kindergarten classrooms, one is in March and one is in May. We have an open door policy with our area Preschools and Head Start programs and a Building Bridges program to assist with a smooth transition for students from pre-k into kindergarten. The “We Both Read” program is a lending library for parents to read with their children. The program is introduced at a workshop in November 2020. Parents are encouraged to make an appointment with the School Based Teacher Leader, Mrs. Largent, when they want to exchange the books. The School Based Teacher Leader is available through appointments to assist any parent with any school related need they may have.**
- **A Parent Resource table is available on the first floor outside room 106 to provide parents with an area to locate information and to provide parents with an opportunity to learn more about family engagement programs and activities.**

## **Section G: BUILDING CAPACITY OF PARENTS**

**Richmond School** will build the parents’ capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

1. Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and
2. Materials and training to help parents to work with their child to improve their child’s achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parent and family engagement
3. Providing assistance to parents of participating children, as appropriate, in understanding topics such as the following:
  - a) The challenging State’s academic standards
  - b) The State and local academic assessments including alternate assessments
  - c) The requirements of Title I, Part A
  - d) How to monitor their child’s progress

e) How to work with educators to improve the achievement of their child

- **The Annual Title I Meeting in the Fall will address curriculum and the topics a-e above.**
- **Monthly parent workshops are held to provide information about the literacy and math programs at Richmond School and how they align with the PA Common Core State Standards. One workshop is dedicated to providing information to the parents about the PSSA, the state assessments. All workshops are geared toward providing parents with an overview of the programs Richmond school uses as well as providing materials to parents to implement what they learned at home. At RTI and IEP meetings parents are shown strategies and given materials to work with their child at home.**
- **Parents are invited to participate in Report Card Conferences to learn about the academic progress and achievement of their child. Report Card Conferences will be held on the following dates: November 18-20, 2020; February 3-5, 2021; April 14-16, 2021. Interim reports will be printed and sent home to parents to inform parents of the academic progress of the students. Interim Reports are available on the following dates: October 6-8, 2020; December 15-17, 2020; March 2-4, 2021; May 4-6, 2021.**

#### **Section H: BUILDING CAPACITY OF SCHOOL STAFF**

**Richmond School** will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

- **School staff will participate in a Professional Development session titled: Working with Parents as Equal Partners. This PD session will take place on November 3, 2020.**
- **Results of the Title I Parent Survey will be shared with staff to inform staff of how the parents responded to the various questions.**

**Richmond School** will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:

- **During monthly SAC meetings, parents may make recommendations regarding parent and family engagement activities. School staff will work in conjunction with the parents to plan and hold the engagement activity as decided upon by the SAC team members.**

**PARENT AND FAMILY ENGAGEMENT POLICY DISCRETIONARY COMPONENTS**

- Involve parents in the development of training for teachers, principals, and other educators to improve the effectiveness of that training.
- Prior to the “Working with Parents as Equal Partners” Professional Development session with school staff, parents will be invited to view the powerpoint presentation and to provide input into the presentation that will be provided to staff. Parents who are members of the SAC will be invited to attend the PD session and to answer questions from the staff that may arise from the presentation.
